King Salman bin Abdulaziz appointed Dr. Al Rabeeah to serve as Supervisor General of the center, which has implemented hundreds of aid programs and projects, alleviating the suffering of millions of people in need worldwide. To date, KSrelief has implemented over 2000 in 90 countries. To date, we work with 175 partners. KSrelief focuses on Women and Children’s projects.

Some of the more noteworthy programs implemented by KSrelief include: MASAM – a large-scale operation in Yemen to remove land mines from populated areas; several specialized centers in Yemen to fit amputees with prosthetic devices, and a program to provide rehabilitation services to former child soldiers in Yemen. The center also provides vital assistance to refugees and IDPs from Yemen, Syria, Myanmar and other countries in crisis.

SAUDI CONJOINED TWINS PROGRAMME:

- Dr. Al Rabeeah is the Head of the Surgical and Multidisciplinary Team for the Saudi Conjoined Twins Programme. Over the last three decades, one hundred and twenty-seven sets (127) have been reviewed, referred from twenty-three (23) countries. Fifty-five (55) have been successfully separated by the team. The programme is fully sponsored by the Saudi Government.

COVID-19 PANDEMIC:

Chaired and participated in many national and international scientific and health committees and councils; notably, he has recently participated in addressing COVID-19 as Chair of the COVID-19 National Committees for the procurement of health supplies, mobile hospitals, ICU expansions, PPEs, medications and vaccinations.
